- Minutes of the Board of Directors meeting dated 14 January 2026 regarding approval of the subsidiary establishment,

RESOLVES

Article 1. Approval of establishment of subsidiary company with the following contents:

1.1 Form of subsidiary company:

- One-member Company Limited with 100% charter capital owned by Vinaconex 25 Joint Stock Company.
- Company name:
 - + Vietnamese name: **CÔNG TY TNHH MỘT THÀNH VIÊN VẬT LIỆU XÂY DỰNG VINACONEX 25**

- 2.3 Appointing **Mr. NGUYEN MINH TUAN** - Deputy Manager of Finance Department of Vinaconex 25 Joint Stock Company to the position of **Member of the Subsidiary Members' Council** and **authorizing to represent 30%** of the Owner's contributed capital at the Subsidiary.
- 2.4 Appointing **Mr. CHAU NGOC HOA** - Director of Vinaconex 25 Quarry to the position of **Director - Legal representative** of the Subsidiary.
- 2.5 Term of appointment: **05 years** from the date of issuance of the Business Registration Certificate.
- 2.6 The representatives of the contributed capital portion is responsible for the compliance with the rights and obligations of the capital contribution representative in accordance with the legal regulations and the Company's internal regulations.

Article 3. The Board of Directors assigns the Subsidiary's Legal Representatives to implement the procedures for the Company establishment registration with the competent State Authorities as stipulated. The Subsidiary Members' Council shall be authorized to perform the Owner's rights to adjust/supplement related the contents subject to the provisions of the Subsidiary's Charter approved in Article 1.5 of this Resolution to ensure the completion of the Subsidiary establishment registration procedures in accordance with the legal regulations.

Article 4. This Resolution takes effect from the signing date. Members of the Board of Directors, the Management Board, and Managers of Departments, Units, and related individuals shall strictly implement this Resolution based on its provisions.
